Notice is hereby given that the Board of Directors of North Austin Municipal Utility District No. 1 will hold a regular meeting on **Wednesday, April 17, 2013, at 6:00 p.m.**, at the District Community Center at 7617 Elkhorn Mountain Trail, Austin, Texas, for the following purposes:

1. Consider approval of the March 18, March 20, and March 27, 2013 meeting minutes;
2. Receive citizens' communications;
3. Discuss and consider approval of revised District Registration Form and authorize filing for same;
4. Receive park and landscape maintenance report, including approval of related proposals;
5. Receive pool and community center report, including approval of related proposals;
6. Discuss and consider approval of pool use agreement with Hurricane Swim Team for 2013;
7. Receive general manager report, including approval of related proposals for maintenance and construction items;
8. Receive bookkeeping report and consider payment for bills, invoices, investments and accounts transfers;
9. Discuss and consider taking any necessary action regarding selection of committee members;
10. Review continuing disclosure information from District's financial advisor and consider any necessary action thereon;
11. Receive a report from the District's engineer;
12. Discuss and consider approval of the following:
  - a. Rattan Creek Trail Expansion and Creek Crossing – Pay Estimate No. 3;
13. Receive restrictive covenants report regarding services rendered, reporting of inspection, consider any necessary action on outstanding violations, including litigation;
14. Consider any necessary action regarding future annexation, limited district conversion, and other City of Austin related issues; and

15. Such other matters as may come before the Board.

The Board of Directors is authorized by the Texas Open Meetings Act to convene in closed or executive session for certain purposes. These purposes include receiving legal advice from its attorney (Texas Gov't Code, §551.071); discussing real property matters (§551.072); discussing gifts and donations (§551.073), discussing personnel matters (§551.074) or discussing security personnel or devices (§551.076). If the Board of Directors determines to go into executive session on any item on this agenda, the Presiding Officer will announce that an executive session will be held and will identify the item to be discussed and provision of the Texas Open Meetings Act that authorizes the closed or executive session.
